Executive Summary

Modeshift has had an incredible year of success and growth with the expansion of the Modeshift Delivery Team, a move into programme delivery, greater levels of engagement with schools, businesses and other organisations, and unprecedented levels of accreditations across all our schemes. In this report we present the results of the Modeshift STARS programme for the 2021/22 accreditation year which runs from 1st September 2021 to 31st August 2022, including delivery across local authorities, schools and businesses.

Over two thirds of local authorities in England (excluding London boroughs and district councils), are currently participating in the Modeshift STARS Education scheme with a total of 81 local authorities out of 118. A further 46 local authorities are now signed up to operating the STARS Business scheme.

The 2021/2022 accreditation year has been a record year for approved STARS applications. 1,785 accreditation applications were approved between September 2021 and August 2022. As of the 1st September 2022, 1,554 sites across England could claim holding a current level of Modeshift STARS accreditation. Across these sites a total of 558,447 individuals (pupils and employees, excluding parents/guardians) are directly impacted by Modeshift STARS School and Workplace Travel Plans.

Focussing on our accredited schools, on average, they have seen their 'Green' (walk/cycle/scoot) modes of travel increase from 58.01% to 59.95%, an increase of 3.2% over the last year, meanwhile their 'Red' (car, car share, motorcycle) modes have seen a reduction from 27.95% to 20.71%, or 25.9% over the same period.

During 2021/22, 11,825 separate 'travel' and 'supporting' initiatives were recorded by schools in the STARS system with over 1.75-million participants taking part in those initiatives.

Introduction

Modeshift is a not-for-profit membership organisation that exists to increase levels of active and sustainable travel in education, business and community settings. Over 800 industry professionals are registered with Modeshift representing the public, private and third sectors. Modeshift works to raise standards of industry delivery, including establishing a national standard for Travel Plans, sharing best practice and recognising excellence amongst its Members, Partners and Supporters.

Modeshift STARS Empowers organisations by providing a centre of excellence for developing, delivering, and monitoring effective Travel Plans. Effective Travel Plans are vital for a healthier, greener, and safer future, as they promote and enable more sustainable and active modes of travel. Modeshift work with thousands of business, education, and community settings across the UK to improve Travel Plan standards, share best practice, and award Modeshift STARS accreditation.

Modeshift STARS Schemes

Modeshift STARS accreditation is awarded to business, education, and community organisations that have demonstrated excellence in supporting walking, cycling, and other forms of sustainable and active travel by developing and implementing an effective Travel Plan.




Figure 1: STARS Accreditation Cycle

There are currently three active schemes; STARS Business, STARS Education, and STARS Residential, with plans to add more schemes in the future. Sites that participate in the STARS schemes achieve accreditation by following the Modeshift STARS Accreditation Cycle (Figure 1) to develop and deliver a Travel Plan.




STARS licence holders and registrants

Local authorities, corporate organisations and consultancies can purchase a licence to operate the Modeshift STARS scheme. Organisations must first be members of Modeshift, then they are able to add a STARS licence* to their annual fees.

The Department for Transport first announced funding for the Modeshift STARS Education scheme in November 2014. Back then, 28 local authorities held a STARS Education licence. This quickly grew to 52 in 2015/16 following the DfT's announcement, and in 2016/17 Modeshift introduced STARS Business licences. The number of STARS licence holders has since grown year on year, with the exception of a drop in 2018/19, to the extent that the 2021/22 accreditation year saw 81 STARS Education and 38 STARS Business licence holders.

This has grown further in 2022/23 as we can report that we already have 81 STARS Education licence holders and 77 STARS Business licence holders with these figures still expanding.





In England there are 118 local authorities (excluding London boroughs and district councils). Of those, 81 (68%) are participating in the Modeshift STARS Education scheme. Separately, Transport for London operates the TfL STARS scheme which operates in all 32 boroughs. As such, three quarters of all local authorities in England are participating in either the Modeshift or TfL STARS scheme for schools.


The STARS Business scheme is open to all 150 local authorities (including London boroughs) and is currently being delivered in 46 (30%) of them. Appendix 1 provides a table with details of all Modeshift local authority memberships and STARS licences.

2021/22 STARS accreditations

The 2021/2022 accreditation year has been a record year for approved STARS applications. 1,785 accreditation applications were approved between September 2021 and August 2022. The previous record over this period was 853 sites which was achieved in 2020/21.

Figure 3 displays the year-on-year growth of the number of successful accreditation applications per accreditation year. The chart shows a drop in accreditations during 2019/20 which can largely be attributed to the COVID-19 pandemic, but the following two years have seen a huge recovery and growth of the scheme. A full breakdown of the figures in Figure 3 can be found in the Momentum Table in Appendix 2.






As of the 1st September 2022, 1,554 sites across England could claim holding a current level of Modeshift STARS accreditation. Across these sites the Travel Plans cover 360,941 pupils, 51,901 members of school staff, and 145,635 employees; therefore, a total of 558,447 individuals are represented in currently accredited Modeshift STARS School and Workplace Travel Plans.

Table 1 below and figures 4, 5 and 6 on the following page display the total number of currently accredited sites for each of the STARS schemes.




STARS Education Accreditations (1st September 2022)

Top performing local authorities

Figure 7 and figure 8 display the 'top 5' local authorities, small (less than 100 schools) and large (more than 100 schools), regarding the total percentage of schools within those local authorities that have currently hold a level of STARS accreditation as of 1st September 2022. Thurrock Council are leading the way amongst small LAs with over 27% of their schools currently accredited. Meanwhile Buckinghamshire have the largest proportion of schools accredited amongst the large LAs with over a fifth (20.69%) of their schools accredited.

Schools modal shift data

The mode of travel to school data for pupils of the 862 currently accredited schools across England has been compiled to provide the average pupil mode of travel to school data for those schools. These schools include a combined total of 360,941 pupils.

The data shows that 44.19% of pupils currently walk to school which is broadly comparable with the National Travel Survey (NTS): 2021ⁱ, although STARS includes a separate category for 'Scooting/Skating' which is classed as 'Walking' in the NTS. The combined figures show 49.21% of pupils walking, scooting, or skating to school.

Car use is considerably lower at 24.56% compared with 37% in the NTS. Significant differences are also observed with cycling which is more than double the NTS figure at 5.02%.




Figure 9: Average modes of pupil travel to school for STARS accredited schools

Key to Modeshift STARS is that the scheme recognises schools that have demonstrated excellence in increasing levels of sustainable and active travel. Schools are rewarded through the accreditation levels, the greater their impact, the higher the level of accreditation they can achieve.

To monitor and assess the impact that a school is achieving, the current year's pupil mode of travel data is compared against a baseline of the average modes of travel that they have recorded for the previous four academic years.

This data allows us to extract an average baseline for all currently accredited Modeshift STARS schools and compare that with average modal splits for the 2021/22 accreditation year. The

results for our top schools, i.e. those that have achieve the 'Very Good Travel Plan' level of accreditation and above are quite remarkable. On average, schools accredited at this level in the 2021/22 accreditation year have seen their 'Green' (walk/cycle/scoot) modes of travel increase from 58.01% to 59.95%, an increase of 3.2%.

The reduction in 'Red' (car, car share, motorcycle) is even more remarkable, with a reduction from 27.95% to 20.71%, or 25.9%. Figure 8 displays these figures as well as the change in 'Amber' (bus, park & stride, train/tube/metro) modes.




Figure 10: Schools Modal Shift – 2021/22 v previous 4-year average.

What these average figures hide is some of the huge achievements that some of our schools have seen when participating in Modeshift STARS. For example, Phillimore Community Primary School in Sheffield, our current National STARS School of the Year for 2022, have seen the percentage of pupils travelling by car reduce from 39.32% in 2017/18 to just 22.55% in 2021/22. Over the same period, walking to school has increased from 56.41% to 65.76%, scooting has gone from 1.00% to 4.00%, and cycling has increased from 0.71% to 1.36%.

STARS Initiatives

During 2021/22, 11,825 separate 'travel' and 'supporting' initiatives were recorded by schools in the STARS system with over 1.75-million participants taking part in those initiatives. 1,900 of recorded initiatives do not have a record of the number of individuals taking part, so the true number of participants is likely to be significantly higher.

Table 3 displays the total number of initiatives delivered by schools over the last 7-years. A total of 74,499 school travel initiatives have been recorded over this period.

In October 2022, those 11 Schools of the Region were invited to the **National STARS School Travel Awards Celebration Event** in London. At the event, 3 schools were named National STARS School of the Year for 2022, Brighton Waldorf School Early Years from Brighton & Hove, Phillimore Community Primary School from Sheffield, and Moseley School and Sixth Form from Birmingham.

Brighton Waldorf School Early Years, Brighton and Hove Council, National STARS Early Years Establishment of the Year 2022

The school has been involved with Modeshift STARS for several years, and over this time, with the support of the local authority, they have seen a change in how children travel to school. They support the school families to make that change to modes of sustainable travel by including events in their newsletter, creating a realistic Travel Plan, talking to the children, and introducing walk, scoot, cycle or park and stride Fridays. In order to support the staff in changing the way they travel to school, they have included Modeshift STARS on their Early Years weekly agenda.

They have embedded the use of sustainable transport, the importance of movement in the outside environment, and the ecological gain of both within the ethos of the school and the experience of the children in the kindergartens. They hope to continue this into the future, and hope that this focus on walking will give the children in their care the best foundation for lifelong health.

Phillimore Community Primary School, Sheffield City Council, National STARS Primary School of the Year 2022

Phillimore provides a safe, pleasant and healthy environment for their school community. Active travel compliments and links with the wider aims and ethos of the school in terms of tackling childhood obesity and levels of inactivity amongst pupils and families. The school is situated in an area of high deprivation, and they know that some forms of green mode travel, such as biking and scootering may not be easily available due to cost. They have therefore focussed on promoting the benefits of walking, not only as an important way to travel, but also as fun, healthy and family based which can be done outside of school. They run a wide range of activities, such as creating a Park and Stride point from the local park, a Y3 walking programme and supporting the Beat the Street campaign. The school have held active travel breakfasts and set up local walks from the nearby Olympic Legacy Park.

These interventions and activities have helped see levels of walking journeys to school increase year on year from 56.41% in 2017/18 to 65.76% in 2021/22, while car journeys have reduced from 39.32% to 22.55% over the same period.

Moseley School and Sixth Form, Birmingham City Council, National STARS Secondary School of the Year 2022

The school champion has worked hard over the years to implement activities that promote sustainable travel. They are always looking for new ways to convey this message and like to include the pupils as much as possible. Following Bikeability training, the school applied for funding to implement a pool bike scheme for those pupils that wish to cycle to school.

In 2021/22, 49.23% of pupils used an active mode of travel to get to school, up from 44.87% in 2017/18

Training and Development

STARS Focus Groups

Modeshift STARS Focus Groups were established in November 2021 in order to gather insights from users, identify gaps and opportunities and help shape improvements to the STARS schemes. Currently three groups have been established, STARS Education, STARS Business, and STARS Residential, with a range of school staff, employees, local authority staff, and consultancies offering their insight. Each group is chaired by a volunteer from the Modeshift Executive Board who represents the requirements of all Members, Partners, and Supporters of Modeshift. These groups now continue to meet on a termly basis to guide the future of the STARS schemes.

STARS Webinars

During the year, the team developed a new programme of 'STARS: Getting Started' webinars that have been delivered, for a fee, to schools, businesses, and local authorities across the country. These new 90-minute sessions give a quick introduction to Travel Plans and the Modeshift STARS schemes, as well as using live system demonstrations to support sites in their first steps towards achieving STARS accreditation.

STARS Business Conference

In March 2022 we delivered a STARS Business conference with over 100 attendees from local authorities, national bodies, charities, corporate organisations, local and national Government. The purpose of the event was share emerging best practice in commuter travel, raise the standards of Travel Plans and grow the STARS Businesses scheme. The next STARS Business Conference will take place in March 2023 in York.

Active Travel Ambassadors (ATA) Scheme

Our DfT funded Active Travel Ambassador (ATA) scheme was established this summer. ATA is a behavioural change programme that is delivered by the Modeshift team in secondary schools in partnership with The Bikeability Trust. The aim is to encourage young people to develop a scheme to promote active and sustainable travel that they will deliver at their school; and to work with The Bikeability Trust to research attitudes towards active travel and Bikeability. The scheme will be delivered to 80 secondary schools across five regions in England. Each school will be supported to apply for a level of STARS Education in the summer of 2023.

As of December 2022, there were 49 schools signed up to the ATA Programme. There are 272 student Ambassadors engaged in delivering activities at their schools. To date 15,787 pupils and 1,831 staff have completed travel surveys which have recorded on the Modeshift STARS system. The ATAs have also conducted interviews with 227 pupils, parents, and members of staff regarding travel issues at their schools, and received responses from 269 pupils and 29 members of staff to the Bikeability Trust 'Attitudes towards Active Travel' survey.

Looking ahead to 2022/23

As mentioned at the start of this report, the STARS accreditation year runs from 1st September to the 31st August each year. This section highlights some of our key planned areas of work leading to the end of Summer 2023.

STARS Healthcare

NHS England have recently joined Modeshift as part of their NHS Net Zero commitments and have purchased Corporate Memberships and STARS Business licences for 30 NHS Trusts and Integrated Care Systems (ICS) across England. This new Trust programme is in addition to the existing NHS sites and other healthcare organisations who have already engaged with STARS Business. Over the next 12-months, a new STARS Healthcare Focus Group will be formed who will be tasked with reviewing the current STARS schemes and designing a new accreditation scheme for healthcare settings that is driven by the industry in partnership with NHS England.

STARS Venues

Discussions have commenced to explore the feasibility a fifth STARS accreditation scheme focussing on sporting and music venues. STARS Venues will focus on the development of Travel Plans that mitigate the impact of travel to and from events that draw large crowds. A number of venues have already expressed an interest in being part of a Focus Group to develop ideas and solutions around an accreditation scheme for venues along with supporting tools to ensure the smooth delivery of events.

National STARS School Travel Awards 2022/23

117 schools that have achieved either the 'Outstanding Travel Plan' or 'Excellent Travel Plan' levels of STARS Education accreditation have been shortlisted for this year's National Awards. They have been invited to attend online Regional Awards events that will take place in March 2023.

Following this, we will have a new group of STARS Schools of the Region for 2023, who will each be invited to our National STARS School Travel Awards Celebration event in Summer 2023.

This year, it is our ambition to also recognise the work and commitment of workplaces and residential developments in the National Awards. As such, work will begin in early 2023 to identify outstanding examples of best practice amongst the sites that have achieved STARS Business and STARS Residential accreditation during the 2021/22 accreditation year.

Resources and communications

The first edition of our new STARS Newsletter was sent to over 3,500 STARS registrants in December 2022. This newsletter will now be published on a termly basis and will contain the latest STARS local authority league tables, case studies from the latest round of accreditation applications across all three STARS schemes, and hints and tips on delivering effective Travel Plans.

In addition, the Modeshift Delivery Team will be working on a range of new and updated guidance documents and resources that can be used by sites when implementing their Travel Plans. There will be a particular focus on creating resources for the STARS Business scheme, including guidance on implementing Travel Plans, and new templates for conducting travel to work surveys.

TravelWise Week 2023

In Summer 2023, Modeshift made an acquisition of Act TravelWise, one of the results being that we are now the UK coordinator of European Mobility Week which runs from the 16-22 September each year, and culminates in World Car Free Day. As such, TravelWise Week will become freely available for any sites that are registered for Modeshift STARS and they will become eligible for the National TravelWise Week Awards.

Although the campaign itself will take place in the 2023/24 accreditation year, plans will begin in early 2023 for the next instalment of TravelWise Week with sites able to register for the campaign from May 2023.

Active Travel Ambassadors (ATA) Scheme

In 2023, deliver of the Modeshift ATA scheme will really ramp up as the Active Travel Ambassador groups begin to deliver their campaigns to peers in order to increase levels of active travel at secondary schools. Throughout engagement, the ATA schools have been supported on their Modeshift STARS journeys, and as a result we expect to see a significant increase in the number of secondary schools applying for STARS Education accreditation in Summer 2023.
